Registration

The registration is provided to the Conference participants. By registering for the 5th EGSC Conference, the Delegates agree to:

1. complete the online registration form with current, complete and accurate information.
2. select the Conference registration type, and if wanted, a social program.
3. receive invoices issued by Conference Organizer upon registration. Payment options will be displayed to you during the registration, as well as sent to you by email.
4. make payment of the registration fees by bank transfer.
5. pay the bank and/or credit card charges, if applicable. Delegates may receive an additional invoice for bank and/or credit card charges if not paid.
6. comply with these Terms and Conditions, applicable laws and regulations relating to the Conference and the venue.

Obligations with regard to safety and publicity

Delegates agree to comply with regulations and rules set by the proprietor of the Conference venue concerning safety, health and environmental protection. If at any point you find yourself unsure of the safety concerns, please contact the Conference Organizer. Delegates agree to refrain from placing or handing out publicity materials, flyers, samples, etc. Delegates agree to refrain from live streaming or webcasting any Conference session without prior written permission from Conference Organizer and from presenters.

Payment and Cancellation

Registration for the 5th EGSC Conference is only complete and confirmed after receipt of the registration fees. By sending the registration form, you confirm to agree with these Terms and Conditions and therefore confirm to pay the registration fee. Payment of every registration is due within 30 days after the registration (submitting the registration form), but should be done before the start of the Conference.

If payment is not received within 30 days or before the first day of the Conference, an additional invoice will be sent, increased with € 20 administrative fees. If payment is not received within 2 months and no email contact has been made with registration@egsconference.com, registration will be deleted - the requirement to pay the handling fee remains unchanged by this deletion.

Registration fee options:

Cancellation charges:

Cancellation made no later than 16st of July 2019 (6pm CET):

Bank and credit card charges and € 20 administrative fee will be deducted from amount you have already paid and/or should have paid.

Cancellation made no later than 16st of August 2019 (6pm CET):

Bank and credit card charges and 50% of paid registration fee will be deducted from amount you have already paid and/or should have paid.

Cancellation made later than 17th of August 2019 (6pm CET):

100% of paid amount. No refund of amount you have paid and/or should have paid will be made.

Data Protection

By registering for the 5th EGSC Conference, Delegates enter their personal information into the database of the Organizer. Organizer collects and stores personal information for the preparation and implementation of the Conference. Delegates' name, affiliation and country of residence will be included in the List of Delegates, distributed at the Conference. Conference Organizer may use the contact details and provide Delegates with information around the Conference. Due to safety reasons, only authorized persons are permitted to access personal and contact details. Organizer will not provide obtained data to third parties. Delegates, who decide to officially submit abstract of their work / paper / presentation for this conference agree to have it published in pdf and/or online and/or printed version of the book of abstracts and/or conference proceedings together with authors' names and their affiliations for each abstract.

Liability

The Organizer does not take responsibility for cancellation of the event in force majeure cases (natural disaster, outbreak of severe contagious epidemic, major strikes, failure of transportation, acts of war, terrorism, government orders or regulations, etc.). The Organizer cannot accept liability for personal accidents or loss of or damage to the private property of Delegates and accompanying persons, either during or indirectly arising from attendance of the Conference.
